All new applicants must schedule a meeting with the School's Executive Director prior to submitting a financial aid application.

- A separate financial aid application must be completed for each student in the family who is seeking aid. (Families need only submit one set of required attachments.)
- Students who are awarded aid for the fall semester will be required to submit a new abbreviated financial aid application no later than December 1, 2010 to be considered for financial aid for the spring 2011 semester.
